Technical assistance from national experts in financing and healthcare and social innovation. Connection with six other award sites around the US. Projects designed to impact upstream social determinants of health to impact health outcomes. We get access and connection with 6 other award sites around the US. <ul style="list-style-type: none"> ○ Focus: Strengthen collaboratives, promote financing innovation, increase impact on health and health equity. ■ Improving community health through innovations in financing. <ul style="list-style-type: none"> ○ Bridging for Health, supported by the Robert Wood Johnson Foundation, is hoping to foster connections among multi-sector stakeholders to rebalance and align investments in health in order to improve population health outcomes ○ Innovations in financing to fund non-traditional health-related initiatives can achieve improvements in population health for all. 		<ul style="list-style-type: none"> ○ Offer evidence-based prevention programs to the community that impact community health. ○ Provide programs where they are needed, to all agencies that want them. ○ Discover a sustainable financing model for all programs, using GBG as a pilot. ■ Next Steps <ul style="list-style-type: none"> ○ Georgia Health Policy Center: TA resource to develop sustainable financing model for community-based prevention activities, especially focused on prenatal and early childhood initiatives ○ Community Prevention and Wellness Committee: Use PAX Good Behavior Game as pilot initiative to test innovative financing models. Extend this financing model, if successful, to other initiatives. ■ ELC Role <ul style="list-style-type: none"> ○ Informed – full transparency and involvement in decision-making ○ Supportive –support initiatives efforts to expand GBG wherever it’s needed, using it as a model to expand other programs that are also needed. ○ Advisory – provides input and consultation –about financing models, about finding funding, who should be “at the table” ○ Involved – volunteer for workgroups (engaging business, CPW membership. 		<p>the expansion of GBG.</p> <ul style="list-style-type: none"> ■ Comment that Sheridan has trained K-4, and certified staff is volunteering to get trained. Willamina has also trained all staff. Yamhill-Carlton has trained all staff. All three schools have sent staff to each other's school to observe how they are implementing it. ■ Comment that Willamina hasn't seen that there are significant ongoing costs. There are costs upfront to train people and to purchase posters and supplies, but there are not many ongoing expenses. ■ Comment that this is a good pilot to create a community culture of addressing issues that are difficult to measure in short-term results. Having the community be aware of the downstream outcomes is important. 		
4:45	Brain Building Community	<p>Keynote by Dr. Kathy Hirsh-Pasek, Senior Fellow at Brookings Institution (nonprofit public policy org in DC), wrote <i>Becoming Brilliant, What Science Tells Us About Raising Successful Children</i></p> <ul style="list-style-type: none"> ■ "Low literacy ... is associated with ... adverse health outcomes and negative effects on the health of the population." (Agency for Healthcare Research and Quality) ■ Language at school entry = best predictor of success in grade 3 in numerous areas ■ Reading scores in grade 3 = strong predictor of lifelong success ■ 30,000,000 word gap by age 3 ■ Content Matters ■ Discouragement vs. Encouragement ■ Quality Matters ■ Fluid & connected verbal and nonverbal exchanges ■ Includes symbols/gestures ■ Involves playful routines & rituals ■ Uninterrupted (no cell phones!) <p>Example: Urban Thinkscape in Philadelphia</p> <ul style="list-style-type: none"> ■ Interactive games in grocery stores ■ Puzzles on benches and bus stops 		Jenn Richter

		<ul style="list-style-type: none"> ■ Parkopoly- human-sized monopoly at public parks to promote number-based play with parents <p>To Address as a Community:</p> <ul style="list-style-type: none"> ■ What resources do we have? ■ How to encourage parents in 2-way communication? ■ How do we put brain-building play in front of parents? <ul style="list-style-type: none"> ○ Libraries are now a parent resource. Libraries could go to low-income neighborhoods and low-income housing and bring programs there. ○ Speech and language pathologists available at relief nurseries, head start centers, child care centers. Currently now only available in Newberg. ○ Waiting areas: school conferences, DMV, clinics. Create activities so that parents have something to do with their kids while they are waiting. Eagle Scout or Cub Scout groups could take this up as a project. ○ Corporate sponsorships. ○ Farmer’s markets and sporting practices. ○ Once a week streets close so that families in the neighborhood can freely and safely play and interact with each other outside. ○ First Friday all the businesses try to have something going on. Music groups, art displays, family engagement scavenger hunts. Done in Newberg. ○ Dayton, Amity, and Sheridan has summer weekly family nights. ○ Need to address mental health issues in parents. Depression and substance abuse in parents is a challenge for them to talk to their children. Focusing on the parent will make it more likely that they engage in the activities. <ul style="list-style-type: none"> ○ 75% of Head Start parents admitted to having had experienced depression. There’s a bilingual brochure for parents to raise awareness of how their mental health affects their children. Suey can share this.
