Questions raised: <ul style="list-style-type: none"> Would partially funding programs be prohibitive to the organizations? Concern about whether a faith based organization would deny services to people with other religious backgrounds or groups. Staff did not identify any indication that services would be limited to only certain faith backgrounds in the application. How many people would receive services with the available funding? Up to 20 people for each house and 2 houses. Which program has more of a success rate? <ul style="list-style-type: none"> Do people re-engage in substance use? All agreed they want to know what other programs are good candidates before considering any partial funding. Four applications still need more discussion.</p> <p>Quorum voted for full funding of three projects, and partial for one. The group presented three versions of how to allocate the remaining funds. To ensure a full slate of recommendations in time for Board consideration, CAC agrees to vote on remaining allocation options via email.</p> <p>Next Steps – An email will be sent out to the CAC group stating what the quorum voted for tonight.
