Funding Discussion: Part II	<p>RFP Review</p> <p>Joint Funding Streams Request for Proposals application shared on screen</p> <p>Historical Context</p> <p>This Joint RFP was begun more than a year ago as part of an overarching goal to have a single RFP cycle and process for all of our different funding streams</p> <ul style="list-style-type: none"> • To keep partners from getting confused when applying for grants • To put onus of administrative decision making around what application fits what specific funding stream best <ul style="list-style-type: none"> ○ Early Learning grants provided by the Early Learning Hub ○ Community Health Improvement Plan grants that the CAC decides on ○ Community Prevention and Wellness Fund which is evidence-based primary prevention programs • This year the joint grant application is ready and will be released in March <p>The goal today is to get approval from this group on the combined RFP knowing that it is attempting to be inclusive of all of the funding streams.
