# 5. CPW Fund Strategic Plan Overview & Approval (D, I, P) Shannon Buckmaster Highlights of presentation:

- The components of the narrative plan (2023-2026 CPW Strategic Plan) include no new content except for identifying annual goals for generating new, matched, or braided funds, and more generalized language regarding future financial structuring options.
- The Ruler Program is an evidence-based approach to social and emotional learning developed at the Yale Center for Emotional Intelligence. It has been implemented in sixteen different states. CPW would fund the program and the schools would implement.
- Pax Good Behavior Game: Implemented in all but 1 school district. A lot of turnover at Yamhill Carlton School District. The Board wants to confirm that the schools that are participating in the program will continue participating in it. There's a strong suspicion that it is not being applied in the schools. YCCO is being responsive to this issue.

### 6. Redetermination Update Discussion (I, P) Seamus McCarthy

The rule has been that members need to apply for Medicaid on an annual basis. This process has been on hold by the Centers for Medicaid Services (CMS) for almost 3 years due to the pandemic. Beginning April 1 we must redetermine if members qualify. We have twelve to fourteen months to redetermine members.

Additional dollars may be needed for redetermination. Assisters are people certified by OHA to help individuals fill out the OHP applications. How long does it take to get certified? To do the process? Then possibly reach out to organizations like Unidos who can do the work. OHA has yet to define the process. OHA did inform us that all CCOs will be receiving a member list. We will then share the list to our Primary Care Providers. First group of letters will be sent out middle of April. All 39,000 members will need to redetermine.
