Update from the SBMH (School Based Mental Health) Investment that the board of directors made in 2020. We will bring a proposal at the next board of directors meeting. Schools are asking for 2 FTE. The contracts are fifty percent CCO funds and fifty percent school funds which come up to 1 FTE.

6. Behavioral Health Services in Schools (I) Lindsey Manfrin and Seamus McCarthy

Lutheran provides the contracts for the elementary schools and HHS provides the contracts for the high schools. There is only 1 school that does not have a contract. Providers are reporting that post pandemic there has been an increase in mental health and a large drop in attendance.

7. Redetermination Update Discussion (D, I) Emily Johnson

Reminder that all members must requalify for Medicaid. There is a lot of confusion going on with members right now. They are receiving letters in the mail that seem contradictory.

Highlights of discussion:

- Outreach timeline has not changed
- Have done targeting outreach on assisters
- Released an RFP (only received 1 application)
- Working with Madison Avenue Collective for promotional materials
- Recently hired a vista to make connections in our community
- Grants will be awarded between May and July
- Reaching out to COFA and Tribal populations

Highlights of Virginia Garcia proposal discussion:

- Hire 4 FTE for call center re-enrollment
- Hire 5 FTE Community Health Workers (CHW)
- Promotional campaign
- Resources will reach Washington and Yamhill Counties
- Also integrating SDOH Screening through the process
- Anticipate keeping the assisters for the 12-14 month process
- They will be open to all community members
